Brunswick Golden Isles Airport has prepared this Emergency Contingency Plan pursuant to §42301 of the FAA Modernization and Reform Act of 2012. Brunswick Golden Isles Airport is filing this plan with the Department of Transportation because (1) it is a commercial airport or (2) this airport may be used by an air carrier described in USC 42301(a)(1) for diversions.

This plan describes how, following excessive tarmac delays and to the extent practicable, Brunswick Golden Isles Airport will:

- Provide for the deplanement of passengers;
- Provide for the sharing of facilities and make gates available at the airport; and
- Provide a sterile area following excessive tarmac delays for passengers who have not yet cleared United States Customs & Border Protection (CBP).

Brunswick Golden Isles Airport is only served by Delta Connection operating Regional Jet Service and has facility constraints that limit our ability to accommodate diverted flights and strongly encourages aircraft operators to contact the airport for prior coordination of diverted flights, except in the case of a declared in-flight emergency. Specific facility constraints include the following: Available jet bridges are capable of connecting to BAe 146, CRJ/ERJ/SAAB, ATR/DASH 8 aircraft.

Plan to Provide for the Deplanement of Passengers Following Excessive Tarmac Delays

Brunswick Golden Isles Airport has air stairs needed for Air Carriers to safely deplane passengers from remotely parked air carrier aircraft. Airport personnel are not trained to assist in the deplanement of passengers using equipment operated by air carriers or contract service providers. We will provide a list of airlines, ground handlers, fixed base operators and others who may have the necessary equipment and personnel to safely deplane passengers as soon as is practicable after receiving requests from such airlines experiencing excessive tarmac delays at the contact number listed above.

Plan to Provide for the Sharing of Facilities and Make Gates Available in an Emergency

Two (2) gates at Brunswick Golden Isles Airport are controlled by the airport and are made available to diverted aircraft on an as-needed basis.

One (1) gate at Brunswick Golden Isles Airport is under preferential use leases to air carriers, and are not fully controlled by the airport during those time periods when the tenant's usage of that gate meets the usage specified in the preferential use lease agreement. We may be able to direct a tenant airline to accommodate another air carrier aircraft at its preferentially-leased gate during those time periods when the tenant airline is neither using, nor is scheduled to use the gates. To the maximum extent practicable, we will direct our tenant air carriers to make gates and other facilities available to an air carrier seeking to deplane at a gate during those time periods the gates are neither in use, nor scheduled to be in use.

Plan to Provide a Sterile Area for Passengers Who Have Not Cleared United States Customs and Border Protection

Brunswick Golden Isles Airport does not have on site CBP personnel nor scheduled international air carrier service however, the airport has a designated area capable of accommodating limited numbers of international passengers. We will coordinate with local CBP officials to develop procedures that will allow international passengers who have not yet cleared United States Customs and Border Protection to be deplaned into this sterile area to the extent practicable.
